AGRICULTURAL CLASSIFICATION INFORMATION REQUIREMENTS

To qualify for the agricultural classification on a property, the property must be used for a bona fide commercial agricultural purpose as of **January 1**, and an <u>Application for Agricultural Classification of Lands</u> (form DR-482) must be completed and returned to this office by **March 1** of the tax year.

Along with your timely filed application, you must provide the following information to verify that the property is being used for a bona fide commercial agricultural use:

- Latest IRS Schedule F-1040 (Farm Income and Expense).
- If you do not have an IRS Schedule F-1040, please provide:
 - Your business's income and expense information, either on a form maintained by the business or on the attached income and expense questionnaire for the prior year.
 - A representative sample of receipts for the care and productivity of the property e.g.: feed, fertilizer, pharmaceuticals, equipment, etc. for the prior year.
 - o Contracts for services related to the agricultural use of the property.
- If the property is leased, provide a copy of the current property lease.
- Additional information relevant to the commercial agricultural property use.

Please be sure to include the name of the business and the type of agricultural use on the application. An area appraiser may also visit the property to document the agricultural use.

Please remember - the statutory filing deadline is March 1!
